

FACTS	<b>WHAT DOES WALTER INVESTMENT MANAGEMENT CORP DO WITH YOUR PERSONAL INFORMATION?</b>
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number and income and debt information</li> <li>▪ Account balances and employment information</li> <li>▪ Credit history and transaction history</li> </ul>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information, the reasons Walter Investment Management Corp. chooses to share, and whether you can limit this sharing.

<b>Who is providing this notice?</b>	Walter Investment Management Corp and its family of affiliated companies listed below.
<b>What we do</b>	
<b>How does Walter Investment protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does Walter Investment collect my personal information?</b>	<p>We may collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>▪ pay your bills or apply for credit</li> <li>▪ write to us or call to inquire on your account</li> <li>▪ purchase an insurance policy through our affiliated agency</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes - information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account — unless you tell us otherwise.
<b>Definitions</b>	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies.
<b>Non-affiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Walter Investment Management Corp does not share with non-affiliates for them to market to you.
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Walter Investment Management Corp does not share with non-affiliates for joint marketing purposes.
<b>Other important information</b>	
<p>Walter's affiliates include: Walter Mortgage Company, LLC, Best Insurors, Inc., Hanover Capital Partners 2, Ltd., Marix Servicing, LLC, Mid-State Capital, LLC, Walter Investment Reinsurance Co, LTD, Walter Investment Holding Company, WIMC Capital, LLC, Hanover Capital Securities, Inc., Hanover SPC-A, Inc., Walter Aquisition, LLC, and the Green Tree Servicing family of companies.</p> <p><u>For CA Residents:</u> In accordance with CA law, we do not share information about you with (i) non-affiliates except as permitted by law such as to service your accounts or (ii) other financial institutions for joint marketing purposes. We also do not share information about your transactions and experience with our affiliates except as permitted by law .</p> <p><u>For VT Residents:</u> In accordance with VT law, we do not share information about you with non-affiliates except as permitted by law such as to service your accounts, nor do we share information about you to affiliates except as permitted by law.</p>
